Lee has won the President award in 2007, the Ted Allen Memorial 2001, Decade of Service 2005. Lee has won 4 State Class titles, 2007-Class-D, 2006 Class-D, 2004 Class-E and 1998 Class-D. He also has won 3 Tournament Of Champion class wins, 1996 Class-B, 1994-Class-C and 1993 Class-F. He has been the Boulder Tuesday night league secretary/statistician 16 years starting 1994. He is the Tournament Director for the Ted Allen tournament since 1999. He has run 16 total tournaments. Lee has played in 5 world tournaments and won 1st. place in Spearfish, SD Class-P and in 1993 won 3rd. place in Perry, GA, Class-M-E3. Lee took over the Ted Allen horseshoe business in 1990.
