Lou has won 3 State Women Singles Championship (2001-2002, 2009), 2 other state titles -Class-C, & Class-D. She has won one State Doubles Championship (2004), won 4 Tournament Of Champions classes and she has won 2 State league championships. She has played in 12 World tournaments as well as pitching in 2 World Championship Classes. Her highest percent game was 96.2% and her highest Consecutive ringers was 26 in 2005. Lou service as the Denver Metro Vice President and has won 7 Denver Metro Leagues Championships. Lou also is one of the feature writers for the Double Ringer.
